Novel Coronavirus (2019-nCoV) – Update March 22, 2020

Dear Sir or madam,

With reference to our communications of February 24 2020; March 09, 10 and 12 2020, we would like to inform you about the current status:

As announced by Prime Minister Conte at a press conference on March 21 2020, the measures and associated restrictions already adopted will be further tightened. This is unfortunately necessary, as the measures taken to date have not yet had the hoped-for effect and the number of infected and dead people continues to rise sharply every day.

All production sectors and plants, not classified as strategic or systemically important will be closed until at least April 03 2020.

The activities carried out by Intercable GmbH, respectively by the companies of the Intercable Group have not been classified as strategic or systemically relevant, which is why we are unfortunately forced to follow the instructions of the public authorities and close our company until further notice. This concerns the companies of the Intercable Group, partner companies and suppliers based in Italy.

The ordered closure of our company is not a voluntary step, is not within our sphere of influence and therefore represents a case of force majeure, which we hereby formally notify you of. As long as the forced, officially ordered closure of our company will continue (currently until April 03, 2020 with the possibility of a further extension), we cannot fulfil our contractual obligations.

In the meantime, if possible, we will already take precautions to be able to restart production as soon as possible if the officially ordered closure of our company ceases to apply. We are closely monitoring all further developments. We will inform you immediately if the situation changes.
